### DIRECTIONS

For use as an all-purpose cleaner, dilute product according to guidelines below:

**LIGHT DUTY CLEANING:** Use 1 oz. per each gallon of water.

**MEDIUM DUTY CLEANING:** Use 2 oz. per each gallon of water.

**HEAVY DUTY CLEANING:** Use 4 oz. per each gallon of water.

Apply product by spray, mop, sponge, cloth or auto-scrubber to surfaces to be cleaned. If necessary, agitate to help remove excessive soils. Wipe dry with clean cloth or rinse thoroughly with clean water after use.

For use as a scrub and recoat cleaner:

Dilute product at 6 oz. per gallon of water. Apply solution to floor using a mop or automatic scrubber. Allow product to dwell for 3 – 4 minutes. Agitate solution using a blue or green pad or brush. Remove solution from the floor with a mop, wet vacuum or automatic scrubber. Rinse with clean water. Allow floor to dry completely prior to recoating floor with finish.

These directions are flexible rather than specific. In many cases a more dilute solution can be used, while for extreme conditions a less dilute solution may be used.

This product meets the maximum content requirements for Volatile Organic Compounds (VOCs) as established by State and Federal regulations.

Dispose of contents/container in accordance with local, state and federal regulations.
